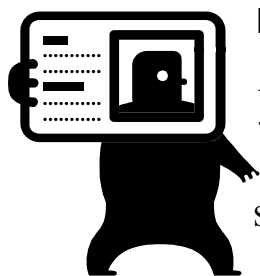

The Labour Department has requested for our confirmation that all membership card holders must be RSO with adequate CPD as stipulated in the Factories and Industrial Undertakings (Safety Officers and Safety Supervisors) regulations before such approval are given.

As such, the Executive Council has decided that any Full Member of SASA whose RSO registration has been suspended due to the lack of CPD will automatically be regraded to Associate Member.
