JLGOSH Meeting with Labour Department

One of the EC members represented SASA to attend the JLGOSH meeting with Assistant Commissioner for Labour (Occupational Safety), Mr. Tso Sing Hin JP, on 7 June at LD's headquarters on the issues of JLGOSH development, RSO CPDs, current accident statistics and concerns arising from SMR Audits.

SASA raised concerns about SMR Adm. Office requesting RSAs to sign "Declaration of Truth" and consequences might incur by missing odd physical condition during SMR audits.

In an abstract, LD replied when a RSA was requested to sign on a "Declaration of Truth" means LD already has an action in mind. As regard to missing of odd physical conditions, it will not lead to direct disciplinary but LD is of the view that verification to physical condition is one of the primer concerns.

SMR Audits and Safety Reviews

In responds to questions from members in relation to submission of Safety Review Reports, LD confirmed that Safety Review Reports shall be submitted to divisional offices while SMR Adm. Office takes care of SMR Audit reports and performance of RSAs.
