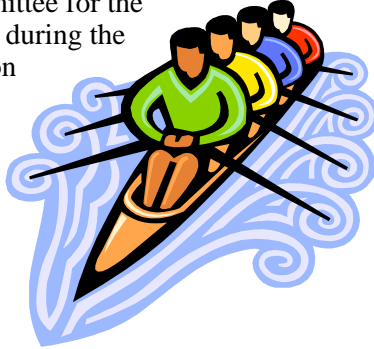


The New Executive Committee

The Safety Auditing Arena

There are over 600 Registered Safety Auditors in Hong Kong and mandatory safety audits have been enforced for over 2 years. The circumstances provide a good habitat for the growth and nurture of the safety auditing profession and the development of more job opportunities. Yet, the situation does not seem to turn out as expected and a number of hurdles are created and a number of deviations are observed.



Safety auditing has not been seen by contractors and factory owners as a means to help them in the establishment and development of their safety management system. It is generally viewed as a legal requirement that they should comply with to avoid prosecution by the Labour Department. It is with this view that the most cost effective or economical way to comply with the law is taken by a lot of auditees.

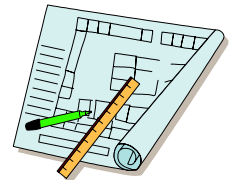
Auditing as a profession has not been properly cultivated and made prominent by the auditors, which can be attributed by the lack of experience of some of the auditors; the lack of professional ethics and most importantly, the failure to provide useful

recommendations to help the auditee in improving their management system.

Auditors go through a relatively short training on the legal requirements and auditing techniques. A format for conducting audits, including the code of ethics, the skills, the report format and the procedures and methodology to be followed are included in the syllabus. The candidate must show their understanding before they can obtain the necessary academic qualification for registration.

Such knowledge and practices are however not adhered to by some practicing auditors, and an extensive variation and diversification of auditing practices are now in the market. The lack of professionalism of some of the audit reports is shocking and appalling. The F&IU (Safety Management) Regulations do not dictate how an audit is to be conducted or how a report is to be presented. The Labour Department has left such decision to the auditors themselves, who, unfortunately, have taken steps to ruin such opportunity for safety auditing to become a profession of its own.

The situation is getting a bit out of control and the integrity of the auditing profession is seriously tarnished by this group of "black sheep". Is this the prime time for auditors to institute some form of self regulatory system to provide a proper and healthy ground for safety auditing to grow?
